Subject: Youth Parliament Programme

The Ministry of Parliamentary Affairs, Govt. of India has been implementing off-line Youth Parliament Programme since 1966 in various educational institutions of the country. The objectives of the programme are to strengthen the roots of Parliamentary democracy, inculcate healthy habits of discipline, develop tolerance of the views of others and to enable the student community to know about the parliamentary system of government functioning.

A web portal on National Youth Parliament Scheme has also been developed by the Ministry of Parliamentary Affairs to increase the coverage of the Youth Parliament Programme. All educational institutions can access the portal at www.nyps.mpa.gov.in to take part in the Youth Parliament Programme. Following are the salient features of the programme:

1. All educational institutions recognized by the Central/State Govt. of the country are eligible to participate in this programme.
2. The registration for participation is done by the educational institutions through the web portal www.nyps.mpa.gov.in
3. E-training modules, videos, photographs and scripts are available on the portal for online self-learning of the participants.
4. After successful registration, the educational institutions can conduct Youth Parliament sittings in their respective institutions.
5. Each student taking part in the sitting will get a Digital 'Certificate of Participation' and Teachers-in-charge and Head of Institution will get a 'Certificate of Appreciation' through the web portal.

All schools having classes IX to XII are requested to register themselves on www.nyps.mpa.gov.in and participate in the programme. The last date for registration is 31.12.2020. Please submit the report of registration for the programme at the following link:

Please find enclosed herewith Ministry of Parliamentary Affairs D.O. letter No.6(5)/2018-YP dated 25th August, 2020 regarding registration of Educational Institutions under Youth Parliament Programme. 2. The Youth Parliament Programme is being run by Ministry of Parliamentary Affairs in various educational institutions with the objective to strengthen the roots of Parliamentary democracy, inculcate healthy habits of discipline, develop tolerance of divergent views and familiarize the student community with the procedures and functioning of Parliament. Hon'ble President launched the Web-Portal of National Youth Parliament Scheme on the occasion to commemorate the 70th Anniversary of adoption of the Constitution of India Samvidhan Diwas' on 26th November, 2019.

3. The Web-Portal aims to bring all educational institutions of the country under the ambit of the Youth Parliament Programme. The portal is accessible at www.nyps.mpa.gov.in All schools having classes from IX to XII are requested to register themselves on www.nyps.mpa.gov.in and participate in the portal based youth parliament programme.

4. Ministry of Parliamentary Affairs has extended the last date for registration for schools having classes IX to XII for Youth Parliament Programme on portal till 31.12.2020 in view of the prevailing situation on account of COVID-19.

Ministry of Parliamentary Affairs has been implementing off-line Youth Parliament Programme since 1966 in various educational institutions of the country.

2. The objective of the programme is to strengthen the roots of Parliamentary democracy, inculcate healthy habits of discipline, develop tolerance of the views of others and to enable the student community to know about the parliamentary system of government functioning

3. Considering the noble objectives of the programme and the important role it plays in disseminating democratic ideals and principles, a web portal on National Youth Parliament Scheme has been developed by the M/o of Parliamentary Affairs to increase the coverage of the Youth Parliament programme to hitherto untouched sections and corners of the country.

4. Hon'ble President of India kindly launched the Web-Portal of National Youth Parliament Scheme on the occasion to commemorate the 70th Anniversary of the adoption of the Constitution of India 'Samvidhan Diwas' on 26th November 2019 in Central Hall, Parliament House, New Delhi in the august presence of Hon'ble Vice President, Hon'ble Prime Minister, Hon'ble Speaker (LS) and Hon'ble Minister of Parliamentary Affairs.

5. All educational institutions can access the portal at www.nyps.mpa.gov.in to take part in the Youth Parliament programme of the Ministry. The salient features of the web-portal are :-

- All educational institutions recognised by the Central/State Govt. of the country are eligible to participate in this programme. The registration for participation is done by the educational institutions through the web-portal.
- E-training modules, videos, photographs and scripts are available on the portal for online self-learning of the participants.
- After successful registration, the educational institutions can conduct youth parliament sittings in their respective institutions.
- Each student taking part in the sitting will get a Digital 'Certificate of Participation' and Teachers-in-charge and Head of Institution will get a 'Certificate of Appreciation' through the web portal.

6. A meeting was held in your office on 17th January, 2020 to discuss the modalities to increase the outreach of Youth Parliament Programme run by the Ministry of Parliamentary Affairs by making it online through the web-portal of National Youth Parliament Scheme (Press release of the meeting is attached). Ms. Anita Karwal was also present during the discussions.

It was decided in the above meeting that D/o Higher Education and D/o School Education & Literacy would work in tandem with the M/o Parliamentary Affairs to increase the outreach of the programme as part of celebrations of 70th Anniversary of adoption of Constitution of India and make all efforts to take up the issue with CBSE, UGC, AICTE, KVS, NVS, State Education Secretaries, Central Universities, etc. for participation of maximum number of institutions.

8. The present participation in the programme stands at 4419 (as on 24.08.2020). Out of 4419, 2163 educational Institutions have been approved by this Ministry for participation in the programme. The remaining educational Institutions have been requested to complete the required formalities first then submit for participation. The last date for registration has been extended to 31.12.2020 in view of the prevailing situation on account of Covid-19.

9. I shall be grateful if you could kindly issue necessary instructions to all concerned to ensure that maximum number of institutions register themselves on the portal before the last date for registration i.e. 31.12.2020.
